The Alabama Department of Postsecondary Education has implemented a policy that requires students to present a valid form of documentation. The required valid form of documentation must be a picture ID, i.e., Alabama Driver's License or Instruction Permit, Alabama identification card, U.S. Passport, etc. If you do not have one of the listed, please contact the Office of Student Services for more options. This can be presented in person, e-mailed to connie.hudson@wccs.edu or sheri.zimmerman@wccs.edu or clear good copy faxed to 334-876-9300. This must be completed as soon as possible.

Placement testing is required for all students who do not meet the ACT Placement Testing Exemptions. If you qualify for any exemption from testing, please provide documentation of exemption (ACT scores) to the Office of Student Services prior to registration. Placement testing for English, mathematics, and reading is facilitated by an examination known as COMPASS. It is an untimed computerized placement test. I encourage you to take advantage of the opportunity to test as soon as possible. Please contact Ms. Shelia Jefferson at 334-876-9295 to schedule your placement test. If you cannot use a computer, please inform Ms. Jefferson.

For your information classes for the Summer Semester 2015 Full and First Mini Sessions will begin Tuesday, May 26, 2015. Second Mini Session will begin Wednesday, July 1, 2015. The Fall Semester 2015 will begin Monday, August 17, 2015.

If you plan to receive a FAFSA (Pell Grant) Award, you will not be eligible to receive a full award until <u>ALL</u> documentation (i.e., GED, Compass Test, High School Transcript and/or College Transcript) is received in the Office of Student Services. WCCS FAFSA (Pell Grant) code is 009980. The e-mail address is <u>www.fafsa.gov</u>. Do NOT wait, complete your online paperwork now. Every student is encouraged to apply for financial aid.

If you are interested in scholarship information, please go to the wccs.edu website, click on Financial Aid, click on Scholarships, and then Wallace Community College Scholarship. Complete application completely as directed. The deadline for WCCS scholarships is March 1, 2015. You must have an ACT of (at least) 22 for Academic Scholarship, ACT of 26 for Presidential Scholarship, ACT of 16 for Technical Scholarship, and Certificate Scholarship is 2.75 GPA.
